I worry about the safety and health of our public parks in the area. I want to see a statement from the Parks Department to explain that a concerted big-picture plan is in place to address expected consequences in the parks. If the shelter doors close after business hours, how will obvious overnight areas be improved to keep them safe? I do not want the parks to become

the overnight facility. I ^{understand} first.

I feel that this shelter may to "solve" one problem but the shelter will cause a lot of other consequences and I really regret that this plan feels forced and disconnected from the problems it will cause. I am worried the nursery school will go out of business, which will be a big loss for the neighborhood, and I worry the parks will suffer, too, which saddens me.
