Please help support this important program by sending your children on June 17.



ATTENTION--LANDLORDS/TENANTS

All rental dwelling units must have proper locks on doors and windows by June 1, 1980. The new city ordinance specifies the locations and types of locks:

- "(h) Every window, exterior door, interior door, and basement hatchway shall be reasonably weathertight, watertight, and rodentproof and kept in proper repair. All door and window hardware shall be installed and maintained in proper working condition. All doors providing access to dwelling units shall be equipped with guarded latch locks. No later than June 1, 1980, the following shall apply in dwelling units all or a portion thereof which are rented:
- 1. Each main entrance door into a dwelling unit shall contain an approved door viewer and door hinges so arranged to be inside the dwelling unit or approved locking pin hinges.
- 2. All doors into each dwelling unit shall have a keyed deadbolt lock with a minimum one (1) inch throw, which is openable with a key on the exterior side of the door and a knob on the interior side of the door. The strike plate shall be held in place by 2 1/2 inch (#12) screws. Patio doors shall have an approved secondary locking device.
- 3. All basement, first, and second story windows and all other windows accessible by balconies, fire escapes, trees or other existing means shall be provided with sash fasteners.
- 4. All double-hung and sliding windows and doors below the second story and all other double-hung and sliding windows and doors accessible by balconies, fire escapes, trees or other existing means shall be equipped with approved window ventilating sash fasteners to allow each window to be locked at four (4) to five (5) inches open. Such windows ventilating bolts or locks shall be movable to permit the window to be fully opened from the inside of the dwelling unit.
- 5. Alternative devices to equally resist illegal entry may be substituted within the approval of the Madison Building Inspection Division and Crime Prevention Bureau."


Through the Friendshop, the book sale, and other activities, we are continuing our efforts to support the Madison Public Library. Your help is important to this effort. Please renew your membership today.

PARK COMMISSION AWARDED FOR SHELTERS

Each year, outstanding designs for park facilities are recognized by Park Maintenance Magazine, a national monthly for professionals in the field. The annual Award of Merit draws entries from all parts of the United States. Entries are judged in four catagories; Swimming Pools, Shelters, Maintenance Buildings, and Restrooms.

In this year's contest, the Madison Park Commission received first place for the design of Glenway Clubhouse and Tenney Bathhouse in the shelter catagory. The Architect involved in the design of these versatile structures is Stuart William Gallaher. The same principal design was utilized for both structures. A third structure at Vilas Park is under construction utilizing the same design concepts. This is not only economical, but enhances the aesthetic value of Madison's beautiful parks. These buildings are fully accessable to the handicapped individual.

The Madison City Park Division, under the direction of Park Superintendent, Daniel R. Stapay, is improving its already distinguished reputation of being the finest park system in the mid-western U.S.

WOMEN'S TRANSIT AUTHORITY

Rape is the most frequently committed violent crime in America today. It has been estimated that in the U.S. a rape occurs once every seven minutes. In 1979, 130 rapes were reported in Madison. This is approximately 11 per month. At least half of all sexual assaults occur at night while women are walking, hitch-hiking, or waiting outside. It is because of this crucial problem of sexual assaults that an alternative is working to increase women's safe mobility at night. This alternative is Women's Transit Authority.

WTA is a rape prevention service which offers free rides to all women who have no other alternative means of transportation. We operate seven nights a week between 7 p.m. and 2 a.m. Being a volunteer organization, WTA is dependent upon a large number of volunteers to maintain and increase its efficiency, and to provide its services. We are staffed by more than 120 volunteers who receive and transmit calls in the office, drive the cars, and work on a variety of committees. The volunteers work one four hour shift weekly or every other week.

Recently WTA has been authorized a fourth car from the University to allow us to increase our services. We are pleased with the additional car; however, this means our need for volunteers has greatly increased. In order to explain the purpose and operation of WTA, along with hopes of reaching new volunteers, we have developed a Community Outreach Program.
