At the annual meeting, we will also review a by-law change which shifts the duties of the three Council officers; The proposed change is:

Section 1. The elected officers of the organization shall consist of:

- 1.1 The President who will direct association activities, chair meeting of the Neighborhood Council and Executive Committee and perform other duties as required.
- 1.2 The Vice-President who will assume the duties of the President at the request of the president or during his absence, and who will perform other duties as agreed upon with the president.
- 1.3 The Secretary-Treasurer who will prepare the minutes of the organization's meetings, issue notices of the association's meetings, maintain all records and files as they pertain to the organization, receive proxies from members 65 and older, and who will administer all monies of the organization.
- 1.4 Three area representatives who will be responsible for distribution of the newsletter within their areas, co-ordinate the annual membership drive within their areas, and serve as active members on the Membership/Social committee.

THE YEAR IN REVIEW

Pam Wrzeski headed the Association's Publicity

Because of the possible location of the MATC campus on East Washington Ave., the association appointed an ad hoc committee to deal with that possibility. Committee members worked with the campus architects to arrive at a design which would make the campus an asset rather than a detriment to the neighborhood. Problems such as increased traffic, pressure on existing housing stock and esthetic factors were considered. However, the Preliminary Environmental Report on the site appeared to ignore these neighborhood concerns. Unless the upcoming Environmental Impact Statement handles these issues to the satisfaction of residents, the committee will reassess its stand.

The new traffic lights on Johnson-Gorham are being installed. They should be in operation before the snow flies. The old lights at Paterson and Johnson should be reinstalled soon, but meanwhile be very careful at that intersection.

If you would like more information about the activities of these and other neighborhood committees, be sure to come to the POTLUCK on Oct.2. Committee heads, old and new, will be on hand to hear your ideas and answer your questions.

The past year has been an active one for several committees of the Tenney-Lapham Neighborhood Association.

As you may know, Lapham School was recommended for closure in January of this year. The education committee worked hard with other groups throughout the city to bring about a year-long moratorium on school closings. Now the moratorium period is drawing to a close. The committee is busy collecting data to build a case for the continuation of Lapham as an elementary school. It is hoped that Board of Education members can be brought to see that the school is essential to the continued revitalization of the neighborhood. Decisions on school closings will be made in December, so much work will be required over the next two months is the committee is to be successful in its efforts.

The housing committee has also had a busy year gathering data and preparing a housing survey for a proposed down zoning of a large part of the neighborhood. Since current density in this area is below the level allowed by current zoning, the committee feels the change is justified to preserve the good balance of home owners and tenants the neighborhood now enjoys. The housing survey, prepared with the cooperation of the City Planning Department, is scheduled to go out to residents within the next month.

Pam Wrzeski headed the Association's Publicity committee in 1977. She does coverage for WORT of the City Council, among other things.

Stan Wrzeski has worked on various Association committees. He is outgoing president of the Madison Development Corporation and is a legislative aide.

Robert Park was an area representative in 1978 and also served as head of the ad hoc committee on MATC. He is a State employee.

David Strandberg was Vice/President-Treasurer of the Association in 1977. He has been active on the Housing Committee and shared the Chair in 1978.

Carol Huber was President of the Association during its first year. She has been active in transportation issues and is a State employee.

Mike Tuten was an area representative in 1978, has been active in transportation issues and other Neighborhood Committees. He is a State employee.

Lynn Schmidt has been active in the School Committee and is currently doing a needs assessment of the neighborhood on alternative school uses. She is a counselor at Briarpatch.

Sue Fieber was Chairman of the School Committee in 1978 and has been working to keep Lapham open.

Donna Jackson has been active on various Association committees and was an area representative in 1977.

Cathy Cole has been working on the neighborhood needs assessment for alternative school uses and is an active member of the School Committee. She is on the UW-Whitewater faculty.

David Flesch is a long-term neighborhood resident and a Madison attorney.



THANKS to all outgoing officers, committee chairs and area representatives. It was a year filled with work -- and most issues are still undecided. To keep our neighborhood an outstanding place to live, the Association will continue to need your help as well as that of all neighborhood residents.

BRIARPATCH

Briarpatch is a runaway and counseling center which works with problems encountered by youths and parents. Our goals are to provide preventative and crisis counseling, temporary shelter, and referral services and to facilitate a reconciliation between parents and young people. We are a walk-in program, that is, our doors are open for anyone to drop in and rap - any time we are open.

Our counselors believe in the right of young people to have confidential services and, to live responsible and productive lives. We believe that young people can, and should be responsible for their life decisions and actions. Our counselors also believe in the right of parents to have access to services which will help further their ability to communicate well with their kids and each other.

HOURS: Counselors are on duty from I:00 pm to midnight. The employed staff are here from 9:00 am on weekdays and these hours are open for runaways as well as agency business. After hours, we can be reached via the telephone, listed below.

STAFF: Briampatch is staffed by approximately 40 volunteer counselors, trained to work in this area. Our volunteers come from diverse backgrounds and occupations. Briampatch also provides field placement for U.W. students and L.E.A.A. interns.

SUPPLEMENTAL PROGRAMS: Weekly recreational outings, summer cance trips, kids' groups, and parent groups are all part of Briarpatch programs.

What we can do for a runaway: 1. If parents or guardian will consent, we can place a youth in a licensed foster home for a temporary stay--up to 14 days. Our foster homes are licensed by Briampatch, Inc. This allows for a "cooling off" period in which parents and youth may consider alternatives. 2. We will contact and arrange a counseling session with parents or quardians upon client's consent (whether or not the youth will be placed in a temporary foster home). 3. We will put youths in need of legal counsel, or advice regarding Protective or Social Services in contact with the appropriate sources. FOSTER HOMES: In order to work towards the reconciliation of families and people, to discover healthy alternatives to problem situations, we need to provide shelter..a safe, legal place where a young person can stay for a maximum of 14 days and work on the immediate problem s/he is experiencing.


We need single or married people who have a concern for young people and/or a curiosity about foster care. All you need is space and a secure income source (no particular level). Care is volunteer - we cannot reimburse except for food expenses when necessary.

Call Briampatch office and one of the staff will set up a time to meet with you and discuss licensing and how our program uses foster parents.

HOME IMPROVEMENT LOANS & HOUSING REHABILITATION SERVICES PROGRAM
